Re: Construction Permit Expirations

Dear Former Permittee:

This is with respect to the expired construction permits listed in the attached Appendix. Section 74.788(b) of the Commission's rules states that:

Any construction permit for which construction has not been completed and for which an application for license or extension of time has not been filed, shall be automatically forfeited upon expiration without any further affirmative cancellation by the Commission.¹

The construction permits listed in Appendix A were automatically forfeited at 12:00 A.M. (local time) on July 14, 2021.² Although the construction permits were for out-of-core channels (above channel 37) and as such could not be licensed on their assigned channels, Spectrum Evolution was permitted to file for displacement.³ Commission records indicate that Spectrum Evolution failed to file for displacement by expiration of the construction permits, and, in fact, stated in its requests that its most recent extension applications be withdrawn because each "CP has an out of core channel for which no in-core displacement has been found."⁴ As a result, Spectrum Evolution no longer has any valid authorizations against which to file a displacement application.

Accordingly, pursuant to section 74.788(b) of the Commission's rules, the construction permits for the facilities listed in the Appendix were **AUTOMATICALLY FORFEITED** and the facilities' call signs have been **DELETED**.⁵ All authority to construct the stations has been **TERMINATED**.
