THIS EXTENSION IS NECESSARY TO DUE TO DELAYS IN COMPLETING TESTING PRIOR TO RETURNING THE NIGHTTIME ANTENNA SYSTEM TO DIRECTIONAL MODE. THE COMMISSION PREVIOUSLY GRANTED AN EXTENSION OF THIS STA ON JULY 22, 2021 (FILE NO.: BESTA-20210706AAM).

SINCE THE MOST RECENT EXTENSION WAS GRANTED, LEGACY'S CONSULTING ENGINEER HAS TRAGICALLY PASSED AWAY FROM COVID-19 CAUSES. SPECIALIZED IMPEDANCE TUNING TEST EQUIPMENT IS NECESSARY TO RETURN THE STATION'S NIGHTTIME BROADCASTS TO DIRECTIONAL OPERATION. PREVIOUSLY, LEGACY'S LOCAL ENGINEER ATTEMPTED TO TUNE THE STATION'S PHASERS HIMSELF, BUT WAS UNSUCCESSFUL WITHOUT THE NECESSARY SPECIALIZED ELECTRICAL IMPEDANCE MEASUREMENT EQUIPMENT.
