Description: EXPLANATION OF REQUEST

1. LICENSEE REQUESTS TO OPERATE FROM AN ALTERNATE LOCATION. SEE FCC SITE CHANGE POLICY. ('STA REQUESTS THAT INVOLVE A CHANGE IN TRANSMITTER SITE MUST MEET THESE CRITERIA: 1. LOSS OF THE LICENSED SITE MUST BE BEYOND THE LICENSEE'S CONTROL. 2. STA FACILITIES MUST CONTINUE TO PROVIDE SERVICE TO THE LICENSED COMMUNITY. 3. STA FACILITIES MUST MAINTAIN, AS CLOSELY AS PRACTICABLE, THE LICENSED SERVICE AREA WITHOUT EXTENDING IT. 4. STA FACILITIES CANNOT INVOLVE THE CONSTRUCTION OF TOWERS INTENDED FOR PERMANENT USE BY THE STATION REQUESTING THE STA.')

HERE, DUE TO SEVERE FINANCIAL LOSSES, ECONOMIC HARDSHIP, AND ACCUMULATING PROPERTY TAXES OWED TO LOCAL TAXING AUTHORITIES, THE PREVIOUS LICENSEE OF KGOL WAS FORCED TO LIQUIDATE ASSETS. THE LAND ON WHICH THE KGOL TOWERS WERE LOCATED WAS SOLD. FM MEDIA VENTURES, THE CURRENT LICENSEE, PURCHASED THE KGOL LICENSE WITHOUT BROADCAST FACILITIES. THE LICENSED SITE IS CURRENTLY BEING REDEVELOPED INTO A COMMERCIAL SHIPPING CENTER, AND THUS IS NO LONGER AVAILABLE FOR PURCHASE OR USE AS A BROADCAST FACILITY.

LICENSEE HAS BEEN CONDUCTING A SEARCH FOR AN ALTERNATE SITE CAPABLE OF REPRODUCING KGOL'S COMPLEX DIRECTIONAL PATTERN, AND IS CURRENTLY CONDUCTING A STUDY TO ASCERTAIN IF PROPERTY AVAILABLE NEAR ALDINE, TEXAS IS SUITABLE FOR CONSTRUCTION OF A NEW FACILITY. IN AN EFFORT TO GET KGOL BACK ON THE AIR AS SOON AS POSSIBLE, LICENSEE HAS ARRANGED TO TEMPORARILY BROADCAST FROM A DIFFERENT TOWER. THIS TOWER IS STRATEGICALLY LOCATED WHERE A LOW POWER NONDIRECTIONAL BROADCAST WILL FULLY COVER THE CITY OF LICENSE AND MUCH OF THE FULL POWER SERVICE AREA.

2. LICENSEE REQUESTS TO OPERATE WITH A TEMPORARY LONGWIRE ANTENNA. SEE FCC RULE 73.1680 'EMERGENCY ANTENNAS.' AM STATIONS MAY USE A HORIZONTAL OR VERTICAL WIRE, OR A SINGLE ELEMENT OF A LICENSED DIRECTIONAL ARRAY, AS AN EMERGENCY ANTENNA.

SEE ATTACHMENT FULLY DESCRIBING PROPOSED OPERATION USING A VERTICAL 241 FOOT LENGTH OF NUMBER 6 WIRE VERTICALLY MOUNTED ON A EXISTING SELF-SUPPORTED TOWER.
