**Re: Mainstreet Media of Colorado, LLC – Request for Extension of Existing Engineering STA; KKCL, Golden, CO (Facility ID No. 161314)**

Audio Division Staff:

Mainstreet Media of Colorado, LLC (“Licensee”) licensee of KKCL(AM), 1550 kHz, Golden, CO (Facility ID No. 161314) (the “Station”), by its undersigned attorneys, hereby requests an extension of its existing Engineering Special Temporary Authority (“STA”), granted pursuant to File No. BSTA-20181210AAU, which the Federal Communications Commission (“FCC”) most recently extended by BESTA-20210709AAL.

Initially, Licensee unexpectedly lost access to its leased tower site for the Station, forcing it to operate from an alternative site. Licensee subsequently located a new site and was in the process of negotiating a lease and preparing a construction permit when the COVID-19 pandemic halted its progress. Despite significant effort by Licensee, it ultimately found that this site would not be viable, and the Commission granted an extension of its STA for this reason, which is now set to expire on January 29, 2022.

Licensee has finally located a site that is suitable for its purposes, and the lease is currently being finalized, but the Station will not be able to resume full operations until construction is complete. Accordingly, Licensee hereby respectfully requests an extension of its existing STA so that it may plan and complete construction at its new site. Licensee will update the FCC expeditiously once it has an update regarding its operational status.

Licensee hereby certifies that neither it nor any party to this application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. § 862. Licensee also hereby certifies that the statements here are true, complete, and correct to the best of its knowledge and belief, and are made in good faith.
