Dear Mr. O'Connor:

This letter refers to: the above-captioned long form application for a new AM station filed by Christyahna Broadcasting, Inc. (CBI) for a new station in Lemon Grove, California¹; the October 11, 2007, Petition to Deny (Petition) filed by Gold Coast Broadcasting, Inc.; and the March 6, 2008, amendment filed by CBI. We will not address the issues raised in the Petition and request that CBI amend the application.

A preliminary review of the long form 301 application reveals that CBI has proposed to change the city of license from Lemon Grove, California, as specified in the short form 175 application BNP-20040129ARM, to Santee, California. This city change is unacceptable as the Media Bureau upheld its previous decision that an AM new station singleton applicant may not specify a new community of license in its initial long form 301 application. See *Rainey Broadcasting, Inc.*, 1800B3-TSN letter dated June 10, 2008, DA 08-1371.

Accordingly, further action on the subject application will be withheld for a period of thirty days from the date of this letter to provide an opportunity to file an amendment to specify the city of license as Lemon Grove, California. Failure to file an amendment or respond within

this time period will result in the dismissal of the application pursuant to Section 73.3568 of the Commission's rules.
