On the behalf of DuPage Radio, LLC ("DuPage"), the Licensee of WCKG (AM), Elmhurst, Illinois (FAC# 32227) ("Station"), this is to respectfully request Special Temporary Authority ("STA") to operate from a separate location. Attached hereto is an email from owner Matt Dubiel, to this Counsel regarding the Station status. As can be seen, this move is necessary due to the loss of its licensed tower site. As a result of that loss, this instant STA is submitted. DuPage proposes the following:

Moving to a new tower .7 Kilometers from current licensed tower.

Requesting 190 watts (.190 Kw) 25% of licensed power

Tower Efficiency: 127.204 mV/m



Per our phone conversation, please find the attached notice from Cook County canceling our lease/license for the WCKG & W272DQ tower site.

Despite our best efforts, Cook County refuses to allow DuPage Radio, LLC any wiggle room and we must vacate both AM 1530 and 102.3 FM this week.

In light of these events outside our control, we must request an STA for AM 1530 WCKG and 102.3 FM W272DQ to remain on the air.
