Radio Station WRSJ, San Juan, Puerto Rico, Facility ID # 54958

Extension of the existing STA for operation of WRSJ with 1 kW and a non-directional antenna is requested. As noted in the earlier applications, WRSJ has not only suffered extensive damage including the loss of one tower from the effects of hurricane Maria, but the local electrical utility is unstable, and operation with licensed facilities is not possible due to the limitations of available electrical service.

Consequently, WRSJ has determined that an application to the Commission for operation fulltime with 10 kW and a two tower directional antenna is necessary, due to the power availability limitations. This application is in the process of preparation, and as soon as a determination of the final design is made will be filed, and the facilities it specifies will be constructed expeditiously thereafter.
