**FEBRUARY 2022 UPDATE:** THE PROCESS OF MODIFICATION OF THE STATION AND IMPLEMENTATION OF THE CHANGES THAT THE COMMISSION AUTHORIZED IN FCC FILE NO. 20200706AAD CONTINUES AT THIS TIME (I.E., MODIFYING THE LICENSE FOR WCHV(AM) IN ORDER TO: SIMPLIFY THE STATION'S ANTENNA SYSTEM FROM DIRECTIONAL TO NON-DIRECTIONAL; REDUCE DAYTIME OPERATING POWER; AND DELETE NIGHTTIME OPERATIONS).

ALTHOUGH SLOWED AT TIMES BY VARIOUS ADVERSE WEATHER CONDITIONS, THE LICENSEE HAS CONTINUED THE WORK IT NOTED IN ITS PRIOR STA REQUEST (SEE FCC FILE NO. **20210806AAC**), CLEARING ADDITIONAL DEBRIS AND UNDERBRUSH, CONDUCTING FIELD STRENGTH READINGS, MAKING DETUNING ADJUSTMENTS TO ITS NON-RADIATING TOWERS.

THE LICENSEE HAS TO THIS POINT USED A CONTRACT ENGINEER FOR THIS AND OTHER WORK. THE LICENSEE IS IN THE PROCESS OF HIRING A FULL-TIME CHIEF ENGINEER. THAT JOB OPENING WAS POSTED LAST WEEK, AND THE STATION IS CURRENTLY RECEIVING RESUMES. THE LICENSEE HOPES TO HIRE A FULL-TIME CHIEF ENGINEER BY MID-MARCH. THE NEW HIRE WILL BE TASKED WITH FACILITATING THE CHANGES TO WCHV(AM) THIS SPRING.

AS SUCH, THE LICENSEE RESPECTFULLY REQUESTS A FURTHER EXTENSION OF STA TO CONTINUE OPERATING AT NO MORE THAN 25% OF AUTHORIZED POWER FOR AN ADDITIONAL 180 DAYS. WCHV(AM)'S PROGRAM SERVICES REMAIN AVAILABLE TO LISTENERS VIA THE LICENSEE'S FM STATION WCHV-FM (FACILITY ID. NO. 61716)AS WELL AS THE INTERNET DURING THE PERIOD OF REDUCED POWER OPERATIONS. GRANT OF THE REQUESTED EXTENSION WOULD SERVE THE PUBLIC INTEREST, AS THE STATION WOULD CONTINUE SERVING ITS COMMUNITY OF LICENSE DURING THIS TIME.
