Request for Extension of STA to operate at reduced transmitter power**

Dear Ms. Dortch:

Monroe Broadcasting Co., Inc., through its counsel, hereby requests extension of the Special Temporary Authority ("STA"), file number BSTA-20190705AAH, to operate FM radio station WMFC, Monroeville, Alabama (fac id 43534) ("Station") with 50% reduced transmitter power, effectively as a Class C3 station, with the facilities set forth in the previously granted STA, and technical report prepared by R. Stuart ("Stu") Graham set forth in the STA.

This STA is necessary as the economic conditions previously outlined continue and the operation with reduced facilities will provide the city of license with city grade signal and otherwise approval is in the public interest in order to assure continued service to the public.

For the foregoing reasons, Monroe Broadcasting Co., Inc. respectfully requests an STA to operate FM radio station WMFC with reduced transmitter power until the Station is able to resume operating pursuant to the terms of its license.
