Dear Ms. Dortch:

On behalf of IHM LICENSES, LLC, licensee of KGOT(FM), Facility ID 12515, Anchorage, AK, (the "Station"), this letter is to request Special Temporary Authority ("STA") to utilize the auxiliary antenna facility of KYMG (BXLH-20060927AOG) as an emergency antenna following a failure in the stations antenna system.

The station normally operates with an antenna that is located upon the antenna of standard band stations KENI/KTZN via an "isocoupler" which has failed and has to be returned to the manufacturer for repair. No change in operating parameters of either standard station was observed as a result of the removal, however both stations are determining power via the indirect method until the system is restored.

The KYMG auxiliary facility at full power of 1,500 watts does not produce a service contour that extends beyond that authorized for KGOT and is thus compliant as an emergency antenna facility.


