**Re: Request for Extension of Special Temporary Authority
WWWL(AM), New Orleans, LA (Facility ID No. 72959)
FCC File No. BESTA-20210706AAH**

Dear Ms. Dortch:

Audacy License, LLC (“Audacy”), licensee of WWWL(AM), New Orleans, LA (Facility ID No. 72959) (the “Station”), hereby requests an additional extension of the above-referenced special temporary authority (“STA”).

The STA authorizes Audacy to operate the Station with its nighttime directional antenna system with parameters at variance pursuant to 47 C.F.R. § 73.62. On November 18, 2020, the FCC granted a construction permit to change the Station’s nighttime operation from directional to non-directional, which would allow the temporary operations to ultimately become the Station’s licensed parameters. *See* FCC File No. BP-20200810AAQ (the “Permit”).

Hurricane-related damage to the Station’s transmitter building, as well as the ongoing coronavirus pandemic, have delayed Audacy from being able to finalize and file the license application to cover the Permit. Accordingly, Audacy respectfully requests that the STA be extended for an additional 180 days to allow enough time for the necessary filing to be completed by Audacy and action taken by the Bureau.

The filing fee for this extension request was paid via the Commission Registration System (CORES). Enclosed is a copy of the online payment confirmation.

Audacy, through its undersigned counsel, hereby certifies that neither Audacy nor any party holding an attributable interest in Audacy is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862.
