Notification of Suspension of Operations and Request for Silent Special Temporary Authority

NCE FM Translator Station WSUP, Platteville, WI (Facility ID 4278)

The Board of Regents of the University of Wisconsin System ("University"), licensee of noncommercial educational FM station WSUP, Platteville, Wisconsin, hereby notifies the Commission of the station's temporary silent status and respectfully requests a six-month grant of Silent Special Temporary Authority ("STA") to maintain the off-air status for more than thirty (30) days.

Station WSUP has been silent since February 27, 2022 due to site access and safety concerns. Specifically, as a result of construction taking place adjacent to the WSUP antenna site on the University's Platteville campus, the University is required to power down the antenna during the construction period for the safety of the workers. During this time, the University will also pursue upgrading WSUP equipment and technology to accommodate a return to on-air operations later this year. A grant of Silent STA will serve the public interest by authorizing WSUP's temporary silent status due to the campus construction project.

The University is a governmental entity and WSUP is a noncommercial educational radio station. The University is therefore exempt from FCC filing fee requirements pursuant to Section 1.1116 of the FCC's rules, and is exempt from FCC regulatory fees pursuant to Section 1.1162 of the FCC's rules.
