
Hoosier AM/FM, LLC hereby files this request for an Engineering STA for WBAT(AM) to operate at variance to the station's licensed facility. A storm severely damaged the tower for WBAT. Consequently, WBAT is required to operate at variance to the station's licensed facilities. Hoosier AM/FM proposes to operate WBAT with a 140-foot long steel wire strung horizontally between two 25 foot high poles with 500 watts. Hoosier AM/FM is filing concurrently with this request an application for construction permit to specify a new tower site for a permanent solution.
