WSKO(AM) Narrative

RADIO LICENSE HOLDING CBC, LLC, THE LICENSEE OF STATION WSKO(AM), SYRACUSE, NEW YORK, RESPECTFULLY REQUESTS AN EXTENSION OF THE WSKO SPECIAL TEMPORARY AUTHORIZATION ("STA") TO ALLOW CONTINUED OPERATION WITH TWENTY-FIVE PERCENT (25%) OF ITS AUTHORIZED NIGHTTIME POWER (1.25 KW) IN A NON-DIRECTIONAL MODE, PURSUANT TO SECTION 73.1615 OF THE COMMISSION'S RULES.

WSKO IS LICENSED TO OPERATE WITH 5 KILOWATTS OF POWER DURING DAYTIME AND NIGHTTIME HOURS UTILIZING A FOUR TOWER DIRECTIONAL ARRAY. AS PREVIOUSLY REPORTED, THE STATION'S LOCAL ENGINEER DETERMINED THAT THE SAMPLE LINES, WHICH ARE QUITE OLD, AND THE ANTENNA MONITOR NEED TO BE REPLACED, AND THE GROUND SYSTEM NEEDS TO BE REPAIRED. SINCE RLH'S LAST SUBMISSION, THE ANTENNA MONITOR HAS BEEN ORDERED AND RLH IS IN CONTACT WITH KINTRONICS ABOUT SUPPLYING THE SAMPLE LINE. ONCE THIS EQUIPMENT IS RECEIVED AND THE SWAMPY GROUND, WHICH IS CURRENTLY TOO WET TO EXCAVATE, IS DRY, RLH ENGINEERS WILL GET TO WORK ON THE GROUND SYSTEM AND REPLACE THE ANTENNA MONITOR AND SAMPLE LINES.

IN THE MEANTIME, RLH RESPECTFULLY REQUESTS AN EXTENSION OF ITS STA SO WSKO MAY CONTINUE TO PROVIDE NIGHTTIME SERVICE, ALBEIT AT REDUCED POWER, TO ITS LISTENERS UNTIL ALL TECHNICAL REPAIRS ARE COMPLETED AND LICENSED NIGHTTIME OPERATION IS RESTORED.
