## K239CR Request to Accept Late-Filed Renewal Application

The Birach Broadcasting Corporation, Licensee respectfully requests the Commission accept this late filed License Renewal Application for K239CR. Simultaneously with the filing of this Application, a request for Special Temporary Authority is filed so as to allow the Licensee continued operation of this Station while this instant renewal is pending with the FCC.

K239CR's Primary Station is KXLQ (AM), Indianola, IA (FAC# 70891) ("KXLQ"). The Licensee timely filed the license renewal for KXLQ on October 1, 2020. At that time, K239CR was still an unbuilt Construction Permit ("CP"). As an unbuilt station, it was *not* on the KXLQ LMS Renewal form pop-up menu for translators associated with KXLQ.

Construction on K239CR was completed in October and a License to Cover Application was filed on October 16, 2020. That License Application was approved on November 10, 2020. So, a license renewal wasn't filed as it was not a licensed station at the filing deadline.

The translator is still "alive" in LMS system. In fact, the Licensee is in the process of for selling K239CR and KXLQ. As one can see K239CR is listed on the assignment application (see attached 314 page 1). The Licensee had *no idea* there was a renewal issue until it's FCC counsel, while preparing for the upcoming closing, discovered this problem.

Under the circumstances, the Licensee respectfully requests WAIVER of the Section 73.3539 Rules regarding license renewal filing deadlines. The Commission has granted late filed applications in the past. See, Email from James Bradshaw, Deputy Chief, Audio Division, FCC Media Bureau, to Cary S. Tepper, Esq., Tepper Law Firm, LLC (July 30, 2021, 11:08 EDT). See also Clear Channel Broadcasting Licenses, Inc., Memorandum Opinion and Order, 26 FCC Rcd 7153, 7157, para 11 (2011) (Clear Channel) (upholding as proper the Bureau's practice of processing a late-filed covering license application for facilities fully completed by the construction deadline through the waiver process); Cranesville Block Company, Inc., Letter Order, 27 FCC Rcd 2018, 2019-20 (MB 2012) (dismissing a petition for reconsideration of an expired construction permit as procedurally improper and treating it instead as a request for waiver). See also, Family Worship Center Church, Inc., Memorandum Opinion and Order and Notice of Apparent Liability for Forfeiture, DA 11-1438, MB August 23, 2011 (reinstatement and grant of translator license renewal.).
