Request for Extension of STA**

Dear Ms. Dortch:

J&V Communications, Inc. (“J&V”), by its counsel, respectfully requests an extension of Special Temporary Authority (“STA”) associated with AM radio station WPRD, Winter Park, Florida (Facility No. 29341) (“Station”) (Original File No. BSTA-20180126AAD, as most recently extended by File No. BESTA-20210806AAI).

As previously reported to the Commission, J&V currently is operating the Station’s nighttime facility in non-directional mode at 25% of licensed effective radiated power (“ERP”) (250 watts). Work on the restoration of the Station’s directional antenna is continuing, with significant progress being made. The pace of restoration efforts was greatly hampered due to local restrictions related to the COVID Omicron variant, and those efforts are still delayed due to the limited availability of resources (repair parts and components) and qualified labor. As work has progressed, J&V has discovered additional issues that are making completion of the repairs difficult. For these reasons, J&V respectfully requests an additional 180 day extension of the STA to operate the Station’s nighttime facility in non-directional mode at 25% of ERP.

While the repairs are ongoing, grant of this extension of STA would be in the public interest, as it will allow the Station to continue providing aural service to listeners in Winter Park,


