REQUEST FOR SPECIAL TEMPORARY AUTHORITY

Station WHSL (FM) Lisman, AL FAC ID 82197

With this letter, Augustus Foundation, Inc. requests Special Temporary Authority (STA) to operate at reduced day and nighttime power on the noted FM station.

Because of damage to the main transmitter, the station is now operating at 1kw power level twenty-four hours. The operations are from the licensed location and the licensed non-directional radiating element. The main transmitter failed, and efforts are being made to purchase a good used, functioning transmitter to permit it to return to the allocated operating power as granted by the commission at the soonest possible time.

The applicant certifies that all parties to the application are in compliance with Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862, the federal law which provides federal and state court judges the discretion to deny federal benefits to individuals convicted of offenses consisting of the distribution of controlled substances. The applicant further certifies no party to the application is subject to a denial of federal benefits that includes FCC benefits pursuant to that section.

Note that the Licensee is non-commercial educational and is 501(c)(3) tax exempt organization, and thus, is exempt from FCC filing fees for requests of this nature.

NOTICE OF RESUMPTION OF OPERATIONS

Station WHSL (FM) Lisman, AL FAC ID 82197

With this letter, Augustus Foundation, Inc notifies the Commission that the FM station herein has returned to operations on March 31, 2022, at 3:10 PM. The licensee has made simultaneous request for Special Temporary Authority to operate the station at variance from the licensed required power.
