Hi Joe,

I am doing some work involving locating some TV antennas on an AM tower and have a question regarding the proper paperwork. An STA application for WQKR-AM was filed to go to the indirect power measurement for the station due to the installation of the TV antennas on the tower. An impedance measurement has been made ahead of the installation of the TV antennas. The measurement will be executed again after the TV antennas are installed as part of the CP condition (See CP authorization FCC file #0000140144 for WDHC-LD (FAC ID 71498)). Then a 302-AM is filed. Does the 302-AM application for the AM station WQKR essentially cancel the indirect power method STA or is some other notification required to notify the FCC that the station is returning to the direct power measurement method? And finally, other than the items required on the 302-AM and the WDHC authorization, is there anything else normally filed to assist with making the paperwork get smoothly executed. The

TV station would like to get their LTC processed as quickly as possible and will request that as part of their application but I don't know if anything else is needed for the AM station?
