**Description:** EXTRAORDINARY CIRCUMSTANCES

A LICENSE TO COVER WBGX(AM)'S NEW CO-LOCATED FM TRANSLATOR W240EI, FACILITY ID NO. 203056 (LMS FILE NO. 0000163147) WAS GRANTED ON NOVEMBER 12, 2021. THE ADDITION OF THE FM ANTENNA, LINE, AND ASSOCIATED ITEMS HAS CHANGED THE TOWER IMPEDANCE FOR WBGX(AM). IMPEDANCE MEASUREMENTS HAVE BEEN DONE AND A MOMENTS METHOD MODEL FOR THE ARRAY HAS BEEN GENERATED. HOWEVER, A REQUIRED FINAL SITE VISIT HAS BEEN DELAYED DUE TO WEATHER AND OTHER SCHEDULING DELAYS CAUSED BY MATERIAL SHORTAGES AND SUPPLY CHAIN ISSUES.
