Although these difficulties have not been fully resolved, the station returned to the air on April 14, 2022, and a resumption notice was filed on April 22, 2022. However, KYWH again requests special temporary authority to remain silent as it continues to face financial difficulties and is in the process of negotiating a sale of the station.
