Description: EXPLANATION

WQOH-FM HAS HAD A SERIES OF MAINTENANCE ISSUES DURING THE PAST THREE MONTHS, AND HAS MADE THE DECISION TO TEMPORARILY SHUT DOWN UNTIL ALL REPAIRS HAVE BEEN SATISFACTORILY MADE AND THE STATION CAN RETURN TO THE AIR FOR CONSISTENT TROUBLE FREE OPERATION. WHEN WE REPAIRED OUR ANTENNA, THE TRANSMISSION LINE WAS DAMAGED. WE ARE IN THE PROCESS OF ORDERING NEW TRANSMISSION LINE.

THE LICENSEE INTENDS TO INSTALL THE NEW LINE WHEN RECEIVED AND THEN TEST THE STATION. A 180 DAY SILENT STA IS REQUESTED SO THAT THE LICENSES CAN BE PRESERVED WHILE REBUILDING TAKES PLACE.

THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY WOULD BE WELL SERVED BY A GRANT OF THIS SILENT STA REQUEST.
