MULTICULTURAL RADIO BROADCASTING LICENSEE, LLC ('MRBL'), RESPECTFULLY REQUESTS A FURTHER EXTENSION OF KXPA(AM)'S SPECIAL TEMPORARY AUTHORIZATION ('STA') TO OPERATE AT TWENTY FIVE PERCENT (25%) OF ITS LICENSED POWER IN THE NON-DIRECTIONAL MODE DURING NIGHTTIME HOURS. THIS REQUEST IS NECESSARY BECAUSE THE FINAL PHASE OF SOUND TRANSIT'S ELECTRICAL WORK FOR ITS LIGHT RAIL TRAIN STATION IS STILL IN PROGRESS.

AS MRBL'S LOCAL ENGINEER REPORTS, SOUND TRANSIT'S ELECTRICAL WORK CONTINUES TO DISRUPT THE ELECTRICAL ENVIRONMENT AND ADVERSELY IMPACT THE OPERATION OF KXPA. AS THIS WORK PERSISTS, MRBL IS MOVING FORWARD WITH ITS TECHNCIAL PLAN BY PURCHASING REPLACEMENT COILS AND CAPS FOR KXPA'S THREE ANTENNA TUNING UNITS ("ATU"), TO AID IN THE FINAL TUNING AND MODELING THAT WILL BE PERFORMED BY ITS TECHNICAL CONSULTANTS, HATFIELD & DAWSON, ONCE THE ATU UPGRADE IS COMPLETED. FURTHER, DUE TO THE ADVANCED AGE OF THE KXPA PHASER, KINTRONICS IS IN THE PROCESS OF BUILDING THE STATION A REPLACEMENT PHASER. MRBL HOPES TO TAKE DELIVERY OF THE NEW PHASER BY MID-SUMMER. SO, IF ALL PROGRESSES AS EXPECTED, MRBL BELIEVES THIS PROJECT WILL BE FINISHED BY YEAR-END, INCLUDING COMPLETION OF THE MOMENT OF METHODS PROOF-OF-PERFORMANCE, WHICH MRBL WILL SUBMIT TO THE FCC.

IN THE MEANTIME, MRBL RESPECTFULLY REQUESTS AN EXTENSION OF ITS STA, PURSUANT TO SECTIONS 73.1635 AND 73.1680(A)(1) OF THE COMMISSION'S RULES, TO OPERATE WITH TWENTY FIVE PERCENT (25%) POWER IN THE NONDIRECTIONAL MODE DURING NIGHTTIME HOURS.
