VOLUNTARY STATEMENT

Dear Audio Staff.

This is a voluntary statement between Craig Rapoza (Cumbre Communications) and Quilvio Perdomo (Perdomo Media Group) in Reference to Deleted DWALE, WALE 990-AM, Greenville, RI Facility ID No. 49128.

In a Letter sent from FCC to Craig Rapoza (Cumbre Communications, Corp.) on April 1, 2014 communicated that the license for the WALE expired on April 1, 2014.1 An application for renewal of this station's license should have been filed by December 1, 20 13,2 and had not been filed as of the date of this letter. Accordingly, on April 1, 2014, the station's license expired by its own terms. All authority to operate Station WALE(AM) has been terminated and the call letters have been deleted from the Commission's database.

Since Cumbre Communications, Corp. was declared in Bankruptcy and not longer exists, it's Ex President Craig Raposa and from Perdomo Media Group Corporation it's President Quilvio Perdomo had a verbal conversation where Quilvio Perdomo expressed his desires to recover WALE 990-AM, Greenville, RI Facility ID No. 49128. Mr. Raposa expressed that Cumbre Communications Corp. is not longer and has not intention to operate radio station anymore but would be pleased if Mr. Perdomo could recover 990-am to Greenville on his own with FCC.

Hoping a reconsideration about a deleted station at least FCC, reassign or open an auction for 990 Greenville and then the community can get back its 990-am since there is not station for Greenville Community.

BACKGORUND:

WALE 990(AM), License for Greenville, RI Facility ID 49128 was cancelled by FCC on April 2014. Cumbre Communications Corp. the past owner lost the station after to be declared in bankruptcy and not to be able to operate and assume of the station's responsibilities.

Quilvio Perdomo a new entrant broadcaster, emergent visionary, entrepreneur from Perdomo Media Group met with Cumbre Communications ex-members and manifested his desires to try to bring the only Station for Greenville 990-am, back to the Community. Cumbre expressed good lock to Perdomo in his challenge and signed a voluntary statement filed with FCC.

Perdomo Media Group is aware that when a license is cancelled and the call letters are deleted, there is not way to get an expired license back. also that FCC has not intention to open a new AM-window. The AM stations are less everyday and the AM-Spectrum looks less congested than in the past.

Perdomo Media has made an engineering research in the area and found that channel 990-am Greenville, RI. is available and no other station performed a modification that affect such channel in the area, CT. RI.MA & Maine.

Perdomo Media Group believes that for FCC might be tedious to deal with AM, for example when FCC opened a window for just for 4 AMs in St. Luis those were revoked from Bob Romanik who recently passed away and No one bid in the auction for them and now the stations are cancelled and deleted. Looks like the AMs are dying but Perdomo thinks AM survive and plan to convert the AM Station to All-Digital.

Perdomo Media Group Asks to FCC **Review and Consider** this Application to bring back 990-AM to Greenville, RI. Perdomo made an evaluation of all necessary things and request to FCC to assign a CP or at least post in an auction the channel 990 in Greenville, RI. That Perdomo is waiting to bid for get it, preserve the AM station and transition it to All-Digital, no other party will be harmed by grant of this and the public interest will be significantly served by a grant of this. Therefore, Perdomo Media requests that the Commission grant this Application for Review and Consideration.
