GENERAL

This office has been authorized by New Spirit Revival Center Ministries, Inc. ("New Spirit"), licensee of Standard Broadcast Station WCCD, Parma, Ohio, to prepare this Engineering Statement in support of a Request for Special Temporary Authority to operate at variance from licensed parameters.

WCCD is licensed to operate on 1000 kHz with a daytime power of 0.5 kW using a four tower directional array (DA-D).

WCCD was recently informed that the towers will be dismantled and the land is being redeveloped by a new owner. The new owner has agreed to permit WCCD to temporarily operate from the #1 (north) tower until construction progress requires that the

tower be removed. An Application for Construction Permit for a permanent site is being

prepared at this time and is expected to be filed shortly.

It is requested that Special Temporary Authority be granted to permit WCCD to

operate nondirectionally from their licensed site with no more than 25% of its authorized

daytime power. The tower as identified by ASR #1058023, will be used as the

nondirectional tower for the STA operation.
