**Re: WPIF(AM), Georgetown, SC. (Facility No. 3900)  
Request for Extension of Engineering Technical STA**

Dear Ms. Dortch:

Waccamaw Broadcasting, LLC, through its counsel, hereby requests extension of the existing Temporary Authority (“STA”) [file no. BSTA-2-211207AAG ] for Station WPIF(AM) [formerly call sign WLMC], Georgetown, SC (fac id 23899) to operate with temporary facilities pending installation of equipment as set forth below.

As set forth in the initial request for an STA, the temporary facilities for WPIF(AM) are at the site of another station of the licensee, station WGTN. This extension of the STA is needed as diplexing equipment needs to be installed to permit combined operation of WPIF(AM) with its companion station WGTN(AM). Accordingly, construction and installation of the diplexing equipment is necessary.

The engineer who is fabricating the combiner/diplexer for this project reports that the filtering and matching for station WPIF is complete but is still fabricating the WGTN side of the system. Absent unusual problems or unforeseen issues, he expects to finish

construction by the end of June 2022. Installation can immediately follow as soon as possible. Accordingly, significant progress is being made.

For the foregoing reasons, Waccamaw Broadcasting, LLC respectfully requests an extension of the existing existing STA for station WPIF(AM). Waccamaw Broadcasting, LLC will inform the Commission when the station is able to resume operating pursuant to the terms of its license.
