Singing River Media Group,LLC, through its counsel, hereby requests extension of the existing Temporary Authority ("STA") [file no. BESTA-20211229AAD] for Station WVNA(AM), Tuscumbia, AL (fac id 19457) to operate with temporary facilities pending completion of construction of an outstanding granted construction permit.

As set forth in the initial request for an STA, an application for modification of the station was granted by the Commisson and a construction permit issued. As an update of the licensee's efforts to build out the CP, the base for the tower and guy wire base anchors are constructed and a new tower was ordered, however, delay in delivery of the tower is continuing to prevent completion of construction. Singing River Media Group, LLC is prepared to finish construction as soon as the tower is delivered. It is

noted that the licensee's companion station, WLAY(AM), will be located on the same tower and an STA is in effect for that station.

For the foregoing reasons, Singing River Media Group, LLC respectfully requests an extension of the exisiting existing STA for station WVNA(AM). Singing River Media Group, LLC will inform the Commission when the construction is complete and a license to cover application is filed to enable the station is operate pursuant to the terms of the construction permit.
