**Description:** EXTRAORDINARY CIRCUMSTANCES WARRANTING FURTHER EXTENSION OF STA

LEGACY COMMUNICATIONS LLC RESPECTFULLY REQUESTS A FURTHER EXTENSION OF THE ENGINEERING STA FOR STATION KRGI(AM), GRAND ISLAND, NEBRASKA (FCC FACILITY ID NUMBER: 32382). THE COMMISSION PREVIOUSLY GRANTED AN EXTENSION OF THIS STA ON FEBRUARY 1, 2022 (FILE NO.: BESTA-20220121AAE).

THIS ADDITIONAL EXTENSION IS NEEDED BECAUSE OF DELAYS IN TESTING PRIOR TO RETURNING THE STATION'S NIGHTTIME ANTENNA SYSTEM TO DIRECTIONAL MODE.

IN 2021, LEGACY'S LONG-TIME CONSULTING ENGINEER UNEXPECTEDLY PASSED AWAY FROM COVID-19. SINCE SPECIALIZED IMPEDANCE TUNING TEST EQUIPMENT IS NECESSARY TO RETURN THE STATION'S NIGHTTIME BROADCASTS TO DIRECTIONAL OPERATION, LEGACY IS REACHING OUT TO OTHER QUALIFIED CONSULTING ENGINEERS WHO POSSESS SUCH EQUIPMENT, TO DETERMINE IF ANY WILL TRAVEL TO GRAND ISLAND, NEBRASKA, TO PERFORM THE REQUIRED WORK AND THE COST OF SUCH SERVICE.

LEGACY IS ALSO CONSIDERING WHETHER TO APPLY FOR FCC AUTHORITY TO PERMANENTLY OPERATE KRGI(AM) AT REDUCED POWER NON-DIRECTIONALLY AT NIGHT, IN A SIMILAR MANNER (ALTHOUGH, PRESUMABLY, AT A LOWER POWER LEVEL) TO HOW THE STATION IS PRESENTLY OPERATING UNDER THE CURRENT STA.

A GRANT OF THIS REQUEST FOR FURTHER EXTENSION OF THE STA TO KEEP THE STATION ON THE AIR AT NIGHT, UNTIL EITHER A NEW ENGINEER IS ENGAGED TO PERFORM THE IMPEDENCE TESTING OR A DECISION IS MADE TO REQUEST A PERMANT REDUCTION IN NIGHTTIME OPERATIONS, WILL SERVE THE PUBLIC INTEREST. THE PROGRAMMING ON KRGI(AM) IS A NEWS/TALK FORMAT. THE PROGRAMMING ON THIS STATION IS IMPORTANT TO THE RESIDENTS OF GRAND ISLAND AND THE SURROUNDING AREAS.

FOR THESE REASONS, LEGACY COMMUNICATIONS LLC RESPECTFULLY REQUESTS A FURTHER EXTENSION OF THE ENGINEERING STA FOR KRGI(AM)'S NIGHTTIME OPERATION.
