## ENGINEERING STATEMENT:

This Engineering Statement supports an application for Special Temporary Authority for AM broadcasting station KSPA, Ontario, CA, Facility ID # 13899, licensed to Intelli LLC.

Having lost its licensed transmitting site, the licensee has diligently searched for a suitable alternative site which could be specified in an application for construction permit, without success. Therefore this report specifies a site for Special Temporary Operation, to allow the station operation with limited facilities.

The site specified is located at 325 N. Mountain Avenue, within the city of Ontario. The facility proposed will consist of an Information Station Specialist TR6000 (15.73) transmitter, and AN16 (ANXX) antenna system. They will be roof mounted on the existing building structure at this address. The roof is 4.5 meters in height, and the AN16 antenna is 4 meters in height, for an overall elevation of 8.5 meters above ground level. The roof is inaccessible and the building will be provided with suitable signage on all sides. The building and roof are of predominately metal construction, and so together with the AN16 antenna system grounding will result in an inverse distance field of approximately 27 mV/m/kW/km. Operation will be with the 10 watt TPO of the ISS TR6000 transmitter. The coordinates (NAD-27) for this location are NL 34° 04' 00" by WL 117° 40' 10". The resulting service contour will be well within the authorized service area of KSPA.

Functionally identical transmitter and antenna systems have been authorised for Special Temporary Authority operation by previous Commission actions including, among others, those for KGDD (BESTA 20200309AAO) and WJBW (BSTA 20200513AAK).
