Finding of No Significant Impact

Dear Mr. Matheson:

This letter concerns the referenced application of Smalltown Broadcasting, LLC ("Smalltown"), as amended, for minor modification of the facilities of Station WDDQ(FM), Adel, Georgia (the "Station"). In the amended application, Smalltown proposes to construct a new 500-foot guyed tower at WDDQ(FM)'s existing site which will increase the heights above ground level, above average terrain, and above mean sea level of the station's antenna; Smalltown proposed a corresponding decrease in the Station's effective radiated power from 6.0 to 2.6 kilowatts. Because the proposed transmitter location is in a 100-year flood plain, Smalltown submitted an Environmental Assessment ("EA") as required by Section 1.1307 of the Commission's Rules (the "Rules")<sup>1</sup> on September 25, 2008. *Public Notice* of the filing of the EA was issued on October 1, 2008.<sup>2</sup> The Commission received no comments in response to the *Notice*.

Upon examination of the EA, we find that the information supplied satisfies the requirements specified in Section 1.1311 of the Rules.<sup>3</sup> Accordingly, pursuant to Section 1.1308 of the Rules,<sup>4</sup> we find that the WDDQ(FM) tower will have no significant environmental impact on the quality of the human environment, and no further environmental processing is warranted. Moreover, we have examined the captioned application and find that it complies with all pertinent statutory and regulatory requirements. Accordingly, the application (File No. BPH-20080613AAK) of Smalltown Broadcasting, LLC for modification of the facilities of Station WDDQ(FM), Adel, Georgia, IS GRANTED.
