Interference Complaint

Dear Counsel:

This letter refers to Marble City Media, LLC's (Marble City) Interference Complaint (Complaint), filed on February 10, 2017, as supplemented. The Complaint alleges that Translator Station W252BE, Tarrant, Alabama (W252BE or Station) is causing harmful interference to the overthe-air reception of Station WFXO(FM), Stewartville, Alabama (WFXO(FM) or Complaining Station).

In the *Translator Interference Order*,⁵ the Commission revised its rules (Rules) relating to FM translator interference complaints and the complaint resolution process. The Commission stated that once effective, all complaints would be decided under the revised Rules.⁶

On October 7, 2019,⁷ the Media Bureau (Bureau) informed Marble City that the Complaint as supplemented did not comply with the Commission's rules (Rules) concerning translator interference. To continue processing the Complaint, the Bureau directed Marble City to file, within 30 days, certain additional information detailed in the *Bureau Letter*. ⁸ The Bureau further informed Marble City that "failure to submit the required information will result in the dismissal of the Complaint."

In a November 6, 2019, letter response, Marble City declined to submit the information requested in the *Bureau Letter*. Specifically, Marble City explained that "both WFXO and W252BE have modified their technical operations, and those changes have necessarily altered the factual situation, including areas of potential interference, since the time of the [filing] of the initial complaint." Marble City further declared that "the *Translator Interference Order* is not relevant to the present proceeding, as the primary issue is no longer interference to WFXO's past facilities, but rather that Shelby does not have a license to operate W252BE."

We find that Marble City has failed to provide the supplemental information required to continue processing the Complaint under the revised Rules. Accordingly, we dismiss the Complaint and Supplements. Regarding Marble City's allegations that the W252BE license has expired, we note that Marble City has raised these allegations in a petition to deny the pending W252BE assignment application and a petition for reconsideration of the W252BE renewal grant.¹² We will address the issue of whether the W252BE license has expired when we act on those petitions. We further note that our action herein dismissing the Complaint and Supplements is taken without prejudice to our action in the other proceedings where we will address the issue of whether the W252BE license has expired.
