Description: REQUESTED ENGINEERING STA EXTENSION. AS NOTED IN BSTA-20190826ABE, WTOX SUFFERED THE LOSS OF TOWER #1 OF ITS 4 TOWER ARRAY DURING SEVERE THUNDERSTORMS ON 8/22/19 WHICH TOPPLED A TREE THAT IN TURN FELL ON TOWER #1 GUY WIRES BRINGING DOWN THE TOWER. WTOX SEEKS TO CONTINUE OPERATIONS AT ND DAY AND NIGHT AT 25% AUTHORIZED POWER AS INDICATED IN THE TECH BOX ON THE ORIGINAL STA USING TOWER #2 UNTIL TOWER #1 CAN BE REBUILT AND THE LICENSED DIRECTIONAL PARAMETERS CAN BE RESTORED. PRIOR LICENSEE HAD PREVIOUSLY EXTENDED STA (BESTA-20210302AAE). CURRENT LICENSEE ACQUIRED WTOX ON 6/11/2021 AND HAS CONTINUED THE PROCESS TO REBUILD TOWER #1 IN ORDER TO RESTORE LICENSED OPERATIONS. LICENSEE HAS ORDERED NEW TOWER FROM ROHN AND IS STILL AWAITING DELIVERY OF TOWER FROM ROHN; LICENSEE ORDERED AND RECEIVED THE NEW TUNING HUT FROM "THE SHED ZONE" WHICH HAS BEEN DELIVERED ON SITE AND IS AWAITING CONNECTION TO NEW TOWER WHEN RECEIVED. LICENSEE HAS ALSO ORDERED ADDITIONAL ELECTRONICS WHICH ARE PENDING DELIVERY AND HAS PUT A TOWER CREW ON STANDBY FOR INSTALLATION ONCE THE STEEL ARRIVES FROM ROHN. A FURTHER EXTENSION OF 180 DAYS OF THIS STA IS REQUESTED TO FACILITATE DELIVERY OF THE TOWER AND GETTING IT ONSITE AND ERECTING SAME.
