On behalf of IHM LICENSES, LLC, licensee of WWNC(AM), 570 kHz, Asheville, NC, Fac ID No. 2946, (the "Station"), this letter is to request Special Temporary Authority ("STA") for operation with an emergency antenna at night after failure of the array switching system.

We request to operate during night mode times with the daytime non-directional facility at a power not to exceed 25% of the authorized night power of 5,000 watts. We are working to repair the system and this request will serve the interests of the public by allowing night service to continue as repairs are made.
