- 1 Ground system consists of 180 equally spaced, buried, copper radials about the base of the tower, varying 48.8 meters to 51.8 meters in length.
- 2 The licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
- 3 Licensee shall accept such interference as may be imposed by other existing 250 watt Class C stations in the event that they are subsequently authorized to increase power to 1000 watts.
