
On behalf of Saga Communications of New England, LLC ("Saga"), licensee of WIZZ(AM), Greenfield, MA (Facility ID No. 54779), this is a request to extend special temporary authority ("STA") to permit Station WIZZ(AM) to continue to operate with reduced power from a different site using a center loaded, bottom fed, vertical whip antenna with a daytime power of 0.150 kW. Saga holds STA (File No. BSTA-20220427AAG) which expires November 1, 2022. Saga cannot construct BP--20210723AAI until a diplexer is received and installed. Due to supply-chain issues, the required diplexer has not been received, so it is necessary to request extension of the STA.

The licensee certifies that neither the licensee nor any party to this application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988 (21 USC § 862).
