Dear Ms. Standley:

This is in reference to the request filed on November 2, 2022. 321 requests a further extension of the STA originally granted on September 20, 2017, as last modified on May 10, 2022, to operate from an alternate site to allow time to file the required FCC Form 301 application to specify a new facility (due to loss of the licensed site).¹ In support of the request, we noted that the station has been silent since January 15, 2022, and 321 stated it has acquired a new tower to be used for the proposed application filing.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is GRANTED, and 321 may commence operations using the following facilities:

Frequency	1300 kHz
Hours of operation	Unlimited
Operating power	0.5 kW (Daytime), 0.25 kW (Nighttime)

232.8 mV/m/kW at 1 km

321 must reduce power or cease operation if complaints of interference are received, and must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. 321 must file an electronic resumption notice in LMS immediately after resuming operations with the parameters given in this STA in order to avoid automatic cancellation of the license if still silent on January 15, 2023.

This authority expires **May 2, 2023**.
