On behalf of High Desert Broadcasting, LLC, licensee of KUTY(AM), Palmdale, CA (FAC: 22011) we would like to extend our current STA to operate KUTY(AM) at variance of its licensed authorization. After surveys of both the KUTY and KOSS sites by new consulting engineer Ben Dawson, of Hatfield and Dawson Engineering, and a thorough review of the original proposal by the previous consulting engineer Mark Mueller to diplex the two stations at the KOSS site, Ben Dawson has proposed an alternate option to rehabilitate KUTY at its current site. He has proposed that KUTY be relicensed with 5kw sat and at least 2kw at night. This will allow the station to operate with the three remaining towers and making modifications to the existing phasor and ATUs. The licensee is nearing the completion of costing out this new proposal which initially appears to be significantly less costly than the original plan to diplex KUTY with KOSS. Based on the foregoing, the licensee respectfully requests that an extension of the current STA be granted.

Applicant certifies that neither applicant nor any party to the application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. Section 862. Once the FCC file number is generated, the licensee will promptly submit the filing fee for this extension of STA request.
