Request for Extension of STA

Dear Ms. Dortch:

J&V Communications, Inc. ("<u>J&V</u>"), by its counsel, respectfully requests an extension of Special Temporary Authority ("<u>STA</u>") associated with AM radio station WPRD, Winter Park, Florida (Facility No. 29341) ("<u>Station</u>") (Original File No. BSTA-20180126AAD, as most recently extended by File No. BESTA-20220322AAG).¹

As previously reported to the Commission, J&V currently is operating the Station's nighttime facility in non-directional mode at 25% of licensed effective radiated power ("ERP") (250 watts). Work on the restoration of the Station's directional antenna is continuing, with significant progress being made. The pace of restoration efforts has been greatly hampered due to continuing limited availability due to back orders and delivery times of resources (repair parts and components) and limited availability of qualified labor. As work has progressed, J&V has discovered additional issues that are making completion of the repairs difficult, as well as the ability to test and adjust the system as necessary. For these reasons, J&V respectfully requests an additional 180 day extension of the STA to operate the Station's nighttime facility in non-directional mode at 25% of ERP.

While the repairs are ongoing, grant of this extension of STA would be in the public interest, as it will allow the Station to continue providing aural service to listeners in Winter Park, Florida and the surrounding areas. J&V will advise the Commission when licensed power to the Station has been restored.
