REASONS FOR STA EXTENSION REQUEST

AS DETAILED IN ORIGINAL STA REQUEST:

WNVL LOST ITS LICENSED TOWER SITE AND WAS OPERATING PURSUANT TO THE ABOVE STA PARAMETERS SINCE JULY 2022 - WNVL RECENTLY EXPERIENCED A FIRE RESULTING IN THE LOSS OF ITS TRANSMITTER, HOWEVER IT HAS SECURED A REPLACEMENT TRANSMITTER AND IS WORKING TOWARDS RESTORATION OF THE CURRENT STA PARAMETERS

IN THE INTERIM, THE FIRE AND ATTENDANT RESTORATION EFFORTS HAVE FORCED A DELAY IN SEEKING A NEW PERMANENT SITE FOR THE FACILITY, BUT WNVL WILL RESUME THAT SEARCH SHORTLY WITH AN EFFORT TO SECURE A DIPLEX OPERATING AGREEMENT WITH ANOTHER BROADCASTER AND SEEK A CONSTRUCTION PERMIT FOR SUCH FACILITY.
