The site for Station WTKI no longer is available. The building and property were sold. The new owner of the property is engaged in major interior demolition, which resulted in the Station's ouster from the licensed site.

The Station has relocated to nearby land at 34-43-38 N, 86-35-58 W. The station is using an HPR.0990 which with full modulation at 250 watts. The installation utilizes a 20-foot 4x4 cemented in the ground and bolted to a steel shipping container at approximately 7 feet. The antenna base sits 15 feet above ground and is bolted to the pole. The ground system provided by the manufacturer is laid out on a wood grid suspended below the antenna base.
