Request for Extension of Engineering STA

Dear Sir or Madam:

Hoosier AM/FM, LLC hereby files this request for extension of the existing Engineering STA for WBAT(AM) to operate at variance to the station's licensed facility (File Nos. BSTA-20220315AAJ and BESTA-20220919AAB). As discussed in the original request for an Engineering STA for WBAT, a storm severely damaged the tower for WBAT. Consequently, WBAT is required to operate at variance to the station's licensed facilities. Hoosier AM/FM proposed to operate WBAT with a 140-foot-long steel wire strung horizontally between two 25-foot-high poles with 500 watts. On March 22, 2022, the FCC granted the Engineering STA request.

On March 16, 2022, Hoosier AM/FM filed an application for construction permit specifying new facilities for WBAT to address the damage to the licensed facilities. On May 31, 2022, the FCC granted the permit application. Hoosier AMFM timely pursued seeking FCC approval for new facilities for WBAT, however the change in economic conditions caused by inflation have delayed ordering the transmission equipment and hiring professionals to construct the facilities.

Attached is the requisite Anti-Drug Abuse Certification.
