Dear Ms. Graeve:

This is in reference to the request filed on March 10, 2023. FB requests an extension of the STA granted on September 15, 2022, to continue operating ND at night with 0.125 kW to allow time to complete all remaining repairs.¹ In support of the request, FB stated that additional time will be required to install a new transmitter and complete all remaining repairs/modifications.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and FB may continue to operate ND at night **with a maximum of 0.125 kW**, with no change to the daytime licensed operation. FB must reduce the nighttime power level further or cease nighttime operations if complaints of interference are received, and must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the

¹ KWBG(AM) is licensed for operation on 1590 kHz with 1 kW daytime (ND) and 0.5 kW nighttime (DA).

Commission's exposure guidelines. *See* 47 CFR §1.1310. FB must submit an e-mail to my attention to note the date the station was able to resumed licensed operations per BZ-19941116AA with negligible changes to all engineering parameters. Otherwise an FCC Form 302 application must be filed with the AudioFilings team to make any necessary changes.

This authority expires on **September 20, 2023.**²

Periods of operation may be subject to independent verification that they in fact occurred.
