Dear Mr. Sloan:

This is in reference to the request filed on March 21, 2023. MSG requests an extension of the STA granted on September 27, 2022, to continue operating from an alternate site location with a temporary antenna to allow time to file the required FCC Form 301 minor change construction permit application.<sup>1</sup> In support of the request, MSG stated that it is planning to sell the station to a new licensee that will file the application to propose a new permanent facility (due to loss the licensed site over four years ago).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and MSG may continue to operate with the following facilities:

Geographic coordinates	33° 35' 40" N, 112° 05' 13" W (NAD 1927)
Frequency	1280 kHz
Hours of operation	Daytime and Nighttime
Operating power	0.01 kW (day and night)
Antenna type	20 foot vertical dipole antenna mounted on building rooftop



<sup>1</sup> KXEG(AM) is licensed for ND operation on 1280 kHz with 2.5 kW daytime and 0.049 kW nighttime.

MSG must reduce power or cease operation if complaints of interference are received, and use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **September 26, 2023**.<sup>2</sup>

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
