AS NOTED IN BSTA-20190826ABE, WTOX SUFFERED THE LOSS OF TOWER #1 OF ITS 4 TOWER ARRAY DURING SEVERE THUNDERSTORMS ON 8/22/19 WHICH TOPPLED A TREE THAT IN TURN FELL ON TOWER #1 GUY WIRES BRINGING DOWN THE TOWER. WTOX SEEKS TO CONTINUE OPERATIONS AT ND DAY AND NIGHT AT 25% AUTHORIZED POWER AS INDICATED IN THE TECH BOX ON THE ORIGINAL STA USING TOWER #2. WTOX INTENDED TO REBUILD TOWER #1 HOWEVER ITS LANDLORD HAS GIVEN NOTICE THAT THE SITE LEASE WILL TERMINATE IN NOVEMBER 2023 AND WTOX HAS LOCATED A NEW TRANSMITTER SITE WITH THE ASSISTANCE OF CONSULTING ENGINEER CHARLES ANDERSON AND WILL BE FILING A 301 MOD APPLICATION FOR THE FACILITY ALONG WITH A NEW ENGINEERING STA TO OPERATE FROM SAID LOCATION WHILE THE 301 IS PROCESSED, GRANTED, BUILT AND LICENSED. AS SUCH, WTOX REQUESTS EXTENSION OF THIS STA UNTIL NOVEMBER 2023 UNTIL THE SITE TRANSITION OCCURS AND THE ABOVE FILINGS ARE COMPLETED.
