Dear Ms. Guel:

This is in reference to the request filed on March 29, 2023. HFCN requests a further extension of the STA granted on September 9, 2021, to continue operating ND with reduced power to allow time to replace a damaged tower, and then file the required FCC Form 302 application.<sup>1</sup> In support of the request, HFCN stated that additional time will be needed to install the new tower and complete all other required repairs before filing the application to update all operating parameters.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and HFCN may continue to operate ND with 0.125 kW (day and night). HFCN must reduce power or cease operations if complaints of interference are received, and must use whatever means are necessary

to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. HFCN must submit an e-mail to my attention to note the date the required FCC Form 302 application was filed (due to the tower replacement).

This authority expires on **October 15, 2023**.<sup>2</sup>

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
