REASONS FOR STA EXTENSION REQUEST

AS DETAILED IN ORIGINAL STA REQUEST:

KKDZ is operating at variance from licensed parameters in anticipation of a move to the newly authorized transmitter site for KKDZ (BP-20210315AAH). As a result of supply chain issues and consulting engineering availability, completion of the new facility authorized by the aforementioned Contruction Permit is still not complete, although some progress was made during the last STA period, and thus KKDZ needs to continue to operate at a variance from its current licensed parameters while it continues to work towards completion of construction and filing of a 302 application for license to cover. In the interim, KKDZ requests further STA authority for an additional 6 months so it can continue to serve the public while completing its construction of new facilities.
