Re: Request for Extension of Special Temporary Authority  
WPWC(AM), Dumfries-Triangle, Virginia (FIN 25995)  
File No. BESTA-20221027AAB

Dear Sir or Madam:

Amin Segundo (“Segundo”), FRN: 0032191686, licensee of WPWC(AM), Dumfries-Triangle, Virginia (FIN 25995) (“WPWC”), pursuant to the Audio Division guidance issued in January 2022,<sup>1</sup> respectfully requests a six-month extension of the Special Temporary Authority (“STA”) authorizing the station to operate nondirectionally with a reduced daytime power not to exceed 1.25 kW and a reduced nighttime power not to exceed 0.125 kW. *See* FCC File Nos. BESTA-20221027AAB (granted Nov. 04, 2022); BESTA-20220502AAH (granted May 04, 2022); BESTA-20211020AAE (granted Oct. 25, 2021); BESTA-20210331AAC (granted Apr. 01, 2021); BESTA-20200909AAK (granted Sept. 15, 2020); BESTA-20200117AAN (granted Jan. 22, 2020); and BSTA-20190625AAC (granted July 09, 2019). The current STA, as extended, is scheduled to expire on May 3, 2023.<sup>2</sup>

Segundo is evaluating options for installation of two replacement towers as on or about March 2019, two towers utilized by WPWC collapsed. WPWC is currently operating pursuant to an STA, File No. 20221027AAB (granted Nov. 04, 2022). Further extension of the STA will allow the new licensee to install two replacement towers and file the required FCC Form 302 applications to update all engineering parameters.

For these reasons, WPWC respectfully requests a 6-month STA extension.
