Dear Counsel:

We have before us the above-referenced application (Application) of Radio7Media, LLC (Radio7), to modify the license of station WLXA(FM), Loretto, Tennessee (WLXA), to change WLXA's community of license from Loretto to Florence, Alabama. We also have before us a Petition to Deny the Application (Petition) filed by Big River Broadcasting Corp. (Big River).¹ As discussed below, we grant the Application.

Background. As noted above, in the Application Radio7 seeks a minor modification of the WLXA license to change its community of license. Because WLXA's current 70 dBµ principal community contour covers more than 50% of the nearby Florence-Muscle Shoals, Alabama, Urbanized Area (Florence UA), it is presumed to serve the Florence UA under the Urbanized Area Service Presumption (UASP) established in the Commission's Rural Radio proceeding.² Radio7 thus requested that we consider the community of license change application from Loretto, Tennessee, to Florence,

Alabama, under Priority (4) of the four allotment priorities applying section 307(b) of the Communications Act.³ Big River filed its initial Petition, contending that a move of an FM station from a community outside the geographic boundaries of an Urbanized Area to the central community in an Urbanized Area does not constitute an intra-Urbanized Area change of community of license, nor is it supported by precedent; that the Application proposed to remove the sole local service from Loretto, Tennessee; and that while the Application proposed to serve a greater population within WLXA's 70 dBµ contour and eliminated a short spacing, it would result in a decrease in population served within WLXA's 60 dBµ service contour.

Staff engineering analysis confirmed that the Application as originally filed would, as Big River asserted, result in a reduction in population served within WLXA's 60 dBµ contour. The staff accordingly sent Radio7 a deficiency letter pursuant to section 73.3522(c)(2) of the rules,⁴ giving Radio7 the opportunity to file an amendment to the Application specifying a preferential arrangement of allotments, and holding the Petition in abeyance. Radio7 then filed an amended Application on September 29, 2022, proposing a site change from the original Application. Radio7 stated that from the new site WLXA would yield an increase in the covered population within the 60 dBµ contour of 5,370 persons, and the site change would eliminate any population loss area.

On October 21, 2022, Big River filed a Supplement to the Petition (Supplement), reiterating its belief that WLXA's coverage of more than 50% of the Florence-Muscle Shoals UA is "merely a rebuttable presumption."⁵ To rebut the presumption, Big River argues that Loretto is "an active and vibrant community, independent of the Florence-Muscle Shoals, Alabama Urbanized Area."⁶ Big River further attaches WLXA's issues and programs lists, which it asserts demonstrate that WLXA primarily covers issues surrounding Lawrence County, Tennessee (in which Loretto is located) and not the Florence UA. In alleging that Loretto is independent of the Florence UA, Big River argues that the UASP is rebutted and, accordingly, that WLXA should be considered to be the sole local radio service at Loretto and not merely an additional service to the Florence UA. As the Commission generally prohibits removing the sole local transmission service from a community,⁷ Big River contends that the Application must be denied.

On February 28, 2023, Radio7 advised the Media Bureau (Bureau) that daytime-only AM station WWLX(AM) (WWLX) was granted a construction permit to change its community of license to Loretto, Tennessee.⁸ Radio7 thus contends that the WLXA move would in any event not remove the sole local

transmission service at Loretto. Big River responded on March 14, 2023,⁹ largely reiterating its earlier arguments, and contending that a daytime-only AM service cannot qualify as a sole local transmission service, as is fulltime WLXA.

Discussion. We deny the Petition. While it is true that the Commission generally prohibits removal of a community's sole service, we have long recognized an exception for intra-Urbanized Area moves.¹⁰ As Radio7 correctly points out, this exception permits an intra-Urbanized Area community of license change if the proponent seeks a move either when both the move-out and move-in communities are located within the geographic boundaries of an Urbanized Area or when the station places a principal community signal over more than 50% of an Urbanized Area.¹¹ Big River is incorrect when it claims that this exception to the UASP only applies to a station licensed to a community that is itself located within the Urbanized Area. In Rural Radio the Commission clearly stated that "applicants will not be required to submit *Tuck* showings where both the current and proposed communities are located in the same urbanized area, or the current facilities cover . . . more than 50 percent of the same urbanized area with a davtime principal community signal."¹² Thus, the fact that WLXA already covers over 50% of the Florence-Muscle Shoals UA makes this an intra-urbanized area move, meaning that the proponent of the move cannot claim to be providing a first local transmission service under Priority (3), merely an additional service to the urbanized area. Accordingly, the proponent of the station move, Radio7 in this case, must demonstrate under Priority (4) of the allotment priorities that the community change represents a preferential arrangement of allotments.¹³ Originally, Radio7 did not demonstrate such a preferential arrangement, as its proposed community move would have resulted in a reduction in covered population. Radio7's September 29, 2022, post-Deficiency Letter amendment, however, does show an increase in covered population, and therefore a preferential arrangement of allotments under Priority (4).¹⁴

Once Radio7 triggered the UASP by covering more than 50% of the urbanized area, the burden shifted to Big River to rebut the presumption. Big River attempts to rebut the presumption by demonstrating that Loretto is independent of the Florence-Muscle Shoals UA, and should therefore not be considered part of or servicing the UA. It therefore argues that the Radio7 proposal is not really an intraurbanized area move, and thus that Radio7 does not qualify for the intra-urbanized area exception to the Commission's prohibition against removal of a community's sole local service. Big River therefore attempts to rebut the UASP by showing that Loretto is independent of the Florence UA, citing the

Threshold Communications case.¹⁵ Using the analysis in *Threshold* as a guide, however, we arrive at the same conclusion the Commission did in that case, namely, that Big River fails to rebut the UASP.¹⁶

Even if we assume that Big River has met its burden of production under factor one of the Rural *Radio* rebuttal evidence ("whether the community at issue is truly independent of the urbanized area").¹⁷ we find that it has failed to meet its burden of production under factor two of the Rural Radio rebuttal evidence ("whether the community has a specific need for an outlet for local expression separate from the urbanized area").¹⁸ To establish this factor, a party must produce evidence such as the community's rate of growth, the existence of substantial local government necessitating radio coverage, and/or the presence of physical, geographical, or cultural barriers separating the community from the remainder of the urbanized area.¹⁹ Big River offers insufficient evidence as to Loretto's rate of growth. In the Petition Big River states merely that Loretto's 2010 Census population of 1,714 "showed an increase from the community's 2000 Census population," without quantifying the rate of increase.²⁰ Loretto's 2020 Census population was 1,739, an increase of 25 persons over the 2010 population, or 1,46%. The record reflects that Loretto has a local government, although Big River tends to overstate how "substantial" its government is and the need for local government coverage.²¹ Finally, in the issues and programs lists for WLXA that Big River attaches to its Supplement, there are no issues or programs specific to the City of Loretto. All issues are area-, county-, or statewide. We conclude that Loretto's city government is not substantial enough to warrant radio coverage.

Big River has also failed to provide evidence of "physical, geographical, or cultural barriers" separating Loretto from Florence, apart from noting that Loretto is in a different state and that it is closer

to the county seat of Lawrence County than it is to Florence.²² Mere distance, however, is not a barrier preventing WLXA from covering the Florence-Muscle Shoals UA, and Big River produces no evidence indicating that the culture of south-central Tennessee is substantially different from that of northwest Alabama. As Big River has not provided evidence that Loretto is appreciably growing, that there are physical, geographic, or cultural barriers separating Loretto from the Florence UA, or that Loretto has substantial government that needs radio coverage, it has failed to meet its burden of production under factor two of the *Rural Radio* rebuttal evidence. Because the UASP has not been rebutted at Loretto. we cannot regard WLXA as a sole local service to the community of Loretto. We thus conclude that the move of WLXA to Florence, serving a larger population under Priority (4), represents a preferential arrangement of allotments.²³

Conclusion / Action. Accordingly, IT IS ORDERED that the Petition to Deny the Application of Radio7Media, LLC, for a minor modification to the license of WLXA(FM), Loretto, Tennessee, filed by Big River Broadcasting Corp., IS DENIED, and that the Application IS GRANTED.
