Dear Mrs. Standley:

This is in reference to the request filed on May 2, 2023. 321 requests a further extension of the STA originally granted on September 20, 2017, as last modified on May 10, 2022, to operate from an alternate site to allow time to file the required FCC Form 301 application (due to loss of the licensed site).¹ In support of the request, we noted that 321 stated it has one new tower in storage and has identified some possible sites for purchase/lease.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA is GRANTED, and 321 may commence operations using the following facilities:

321 must reduce power or cease operation if complaints of interference are received, and must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310.

This authority expires **November 1, 2023**.²

These log entries must be maintained for a minimum of two years as specified in 47 CFR § 73.1840(a), unless a longer retention period is requested by the staff. Periods of operation may be subject to independent verification that they in fact occurred.
