Dear Mr. Trujillo:

This is in reference to the request filed on April 28, 2023. ACP requests a further extension of the STA granted on February 21, 2020, to continue operating using the existing WHAT tower with temporary parameters to allow time to file the required FCC Form 302 application.¹ In support of the request, ACP stated that an assignment application has been filed, and that additional time will be needed to complete all remaining construction steps and then file the application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of the STA IS HEREBY GRANTED, and ACP may continue to operate with the ND facilities specified in BP-20220601AAG using a reduced

daytime power of 1.2 kW, along with the previously authorized 1.2 kW critical hours and 0.007 kW nighttime power levels. ACP must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310.

This authority expires on **November 4 2023**.²
