Dear Ms. Dortch:

On behalf of IHM LICENSES, LLC, licensee of WRKO (AM), 680 kHz, Boston, MA, Facility ID No. 1902, (the "Station"), this letter is to request Special Temporary Authority ("STA") for intermittent operation of the station as non-directional at 25% of licensed power in day and night mode from a select tower in the existing array during tower painting to ensure worker safety. The non-directional tower to be operational will be selected based upon which tower is being painted at that point in time.

It is expected to take 4 weeks to accomplish the painting operation, however we request 90 days out of an abundance of caution and will file our letter of resumption upon completion of the work. This operation is consistent with 73.1680(b) as we paint the towers of the station.
